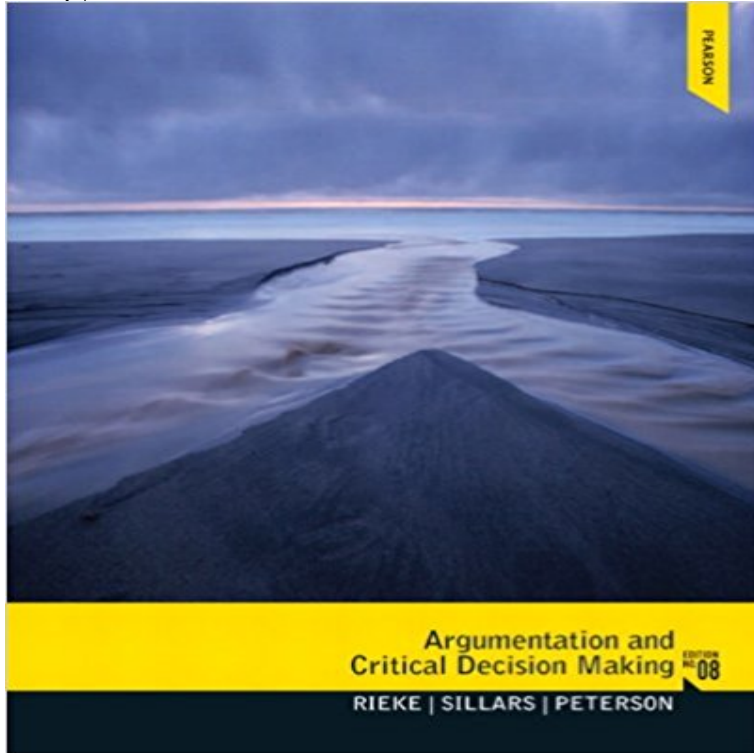


# Argumentation and Critical Decision Making (8th Edition)
