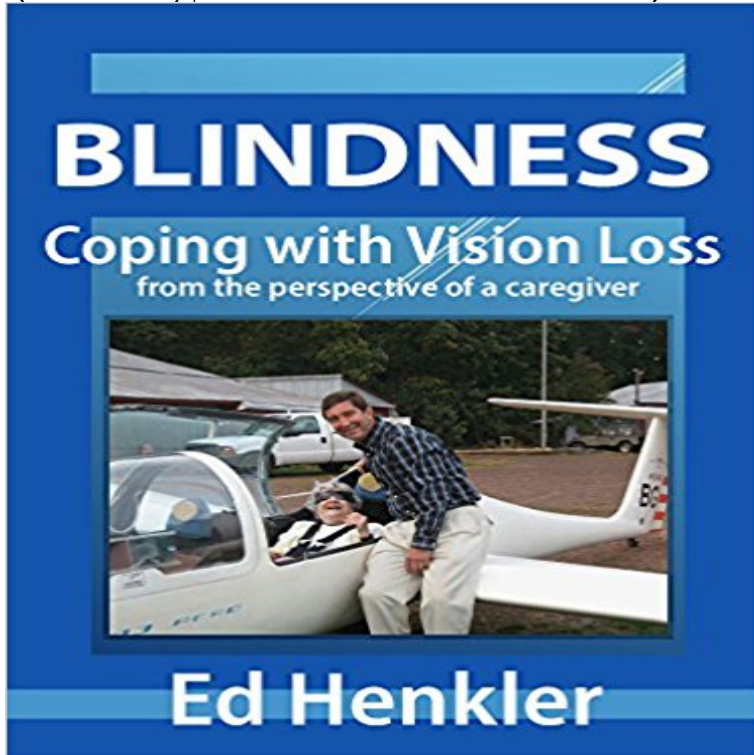


Blindness: Coping with Vision Loss: From the perspective of a caregiver (Thriving with Blindness Book 1)
