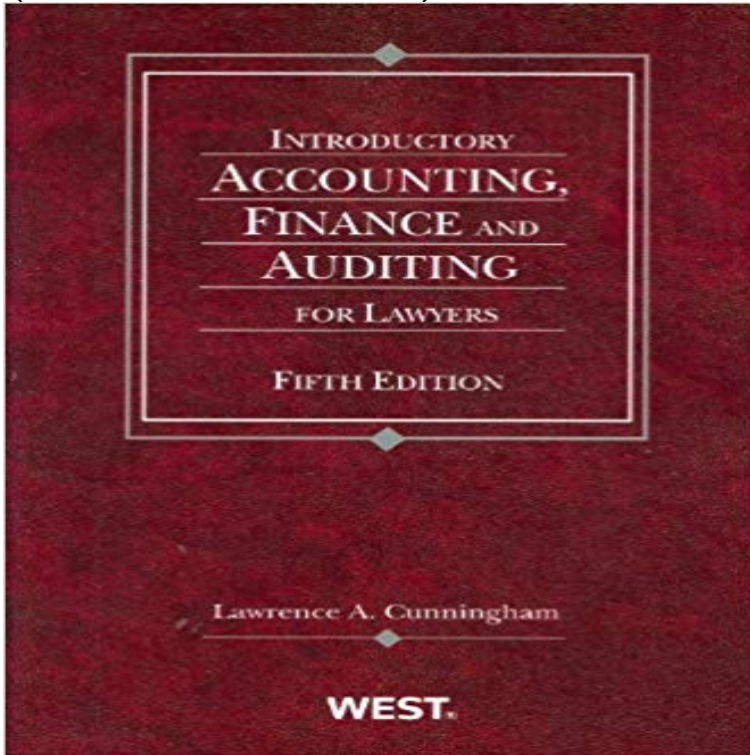


Introductory Accounting, Finance and Auditing for Lawyers, 5th (American Casebook)
