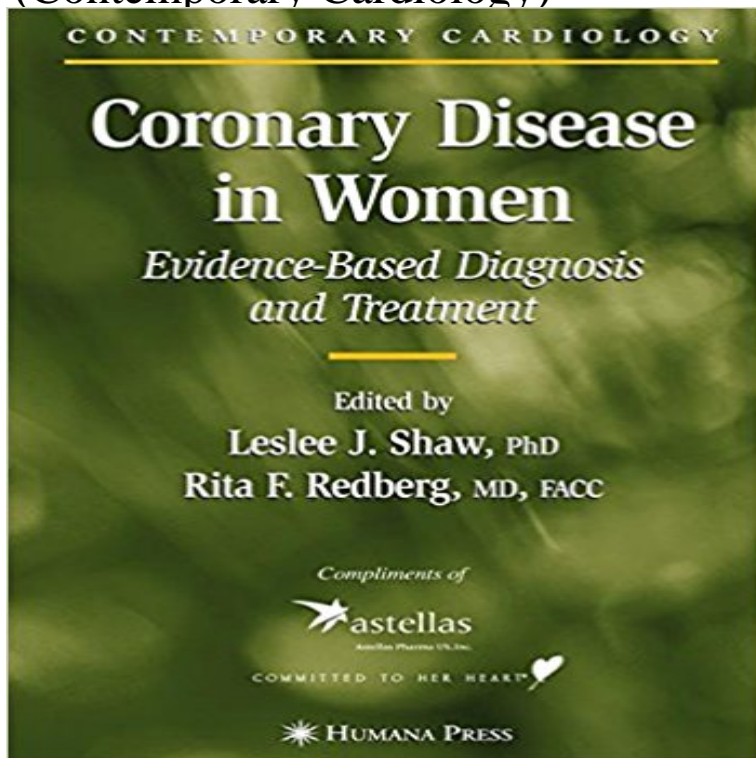


# Coronary Disease in Women: Evidence-Based Diagnosis and Treatment (Contemporary Cardiology)
