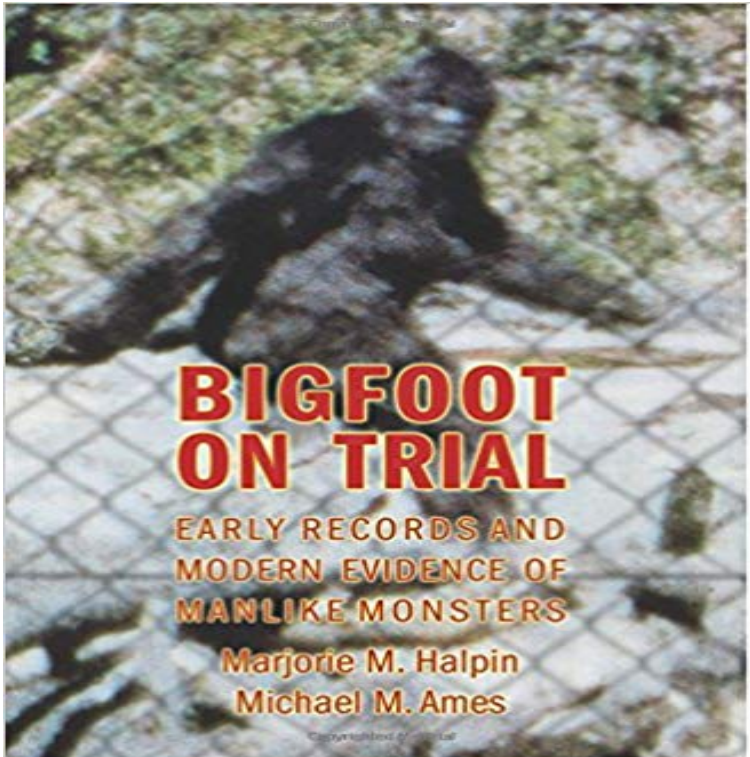


# Bigfoot On Trial: Early Records and Modern Evidence of Manlike Monsters
