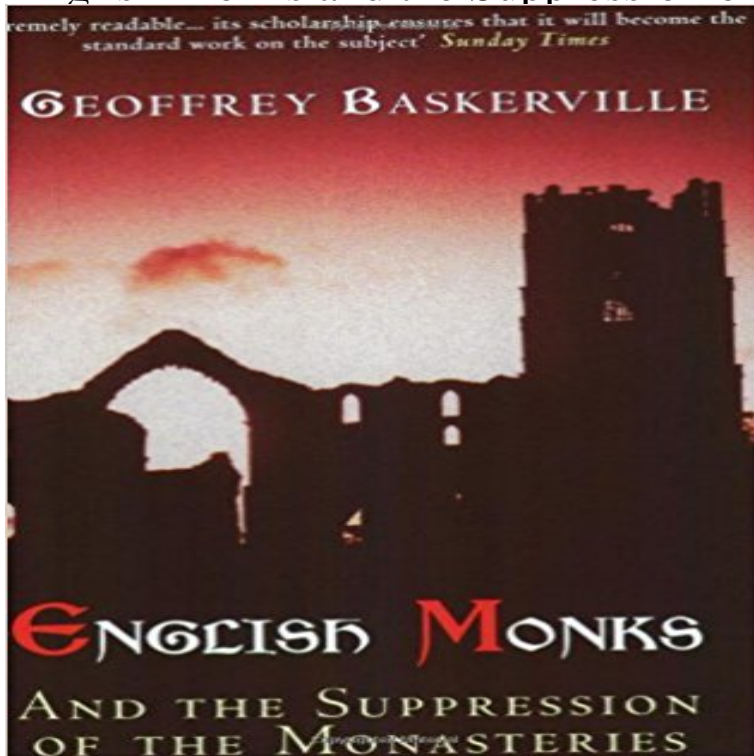


# English Monks and the Suppression of the Monasteries
