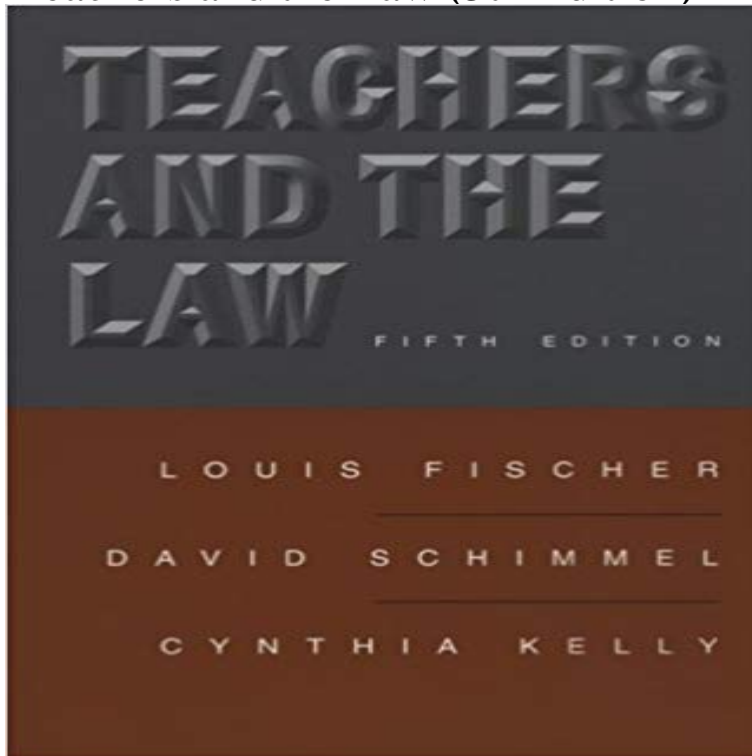


Teachers and the Law (5th Edition)
