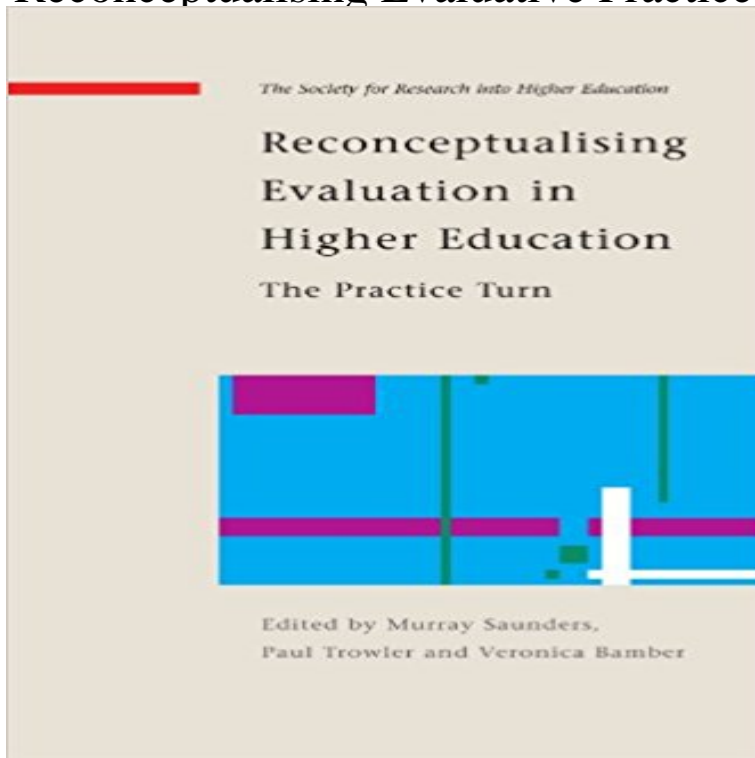


Reconceptualising Evaluative Practices in HE: The Practice Turn (SAP)
