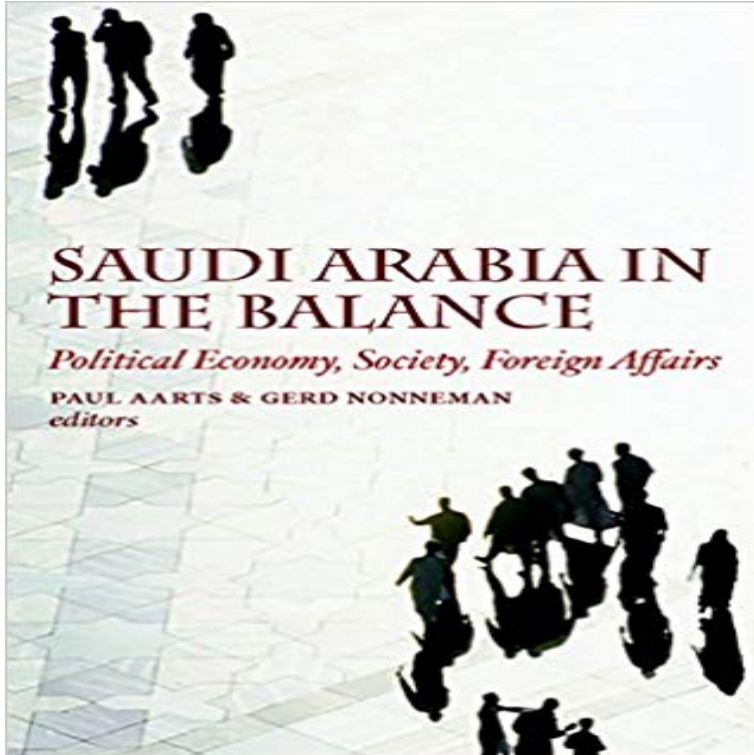


Saudi Arabia in the Balance: Political Economy, Society, Foreign Affairs
