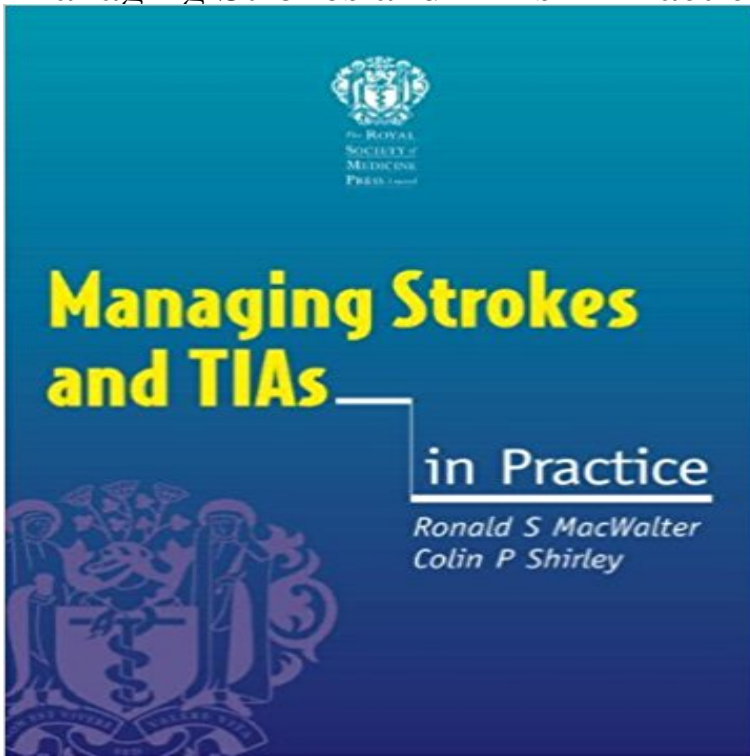


## Managing Strokes and TIAs in Practice (In Practice S.)
