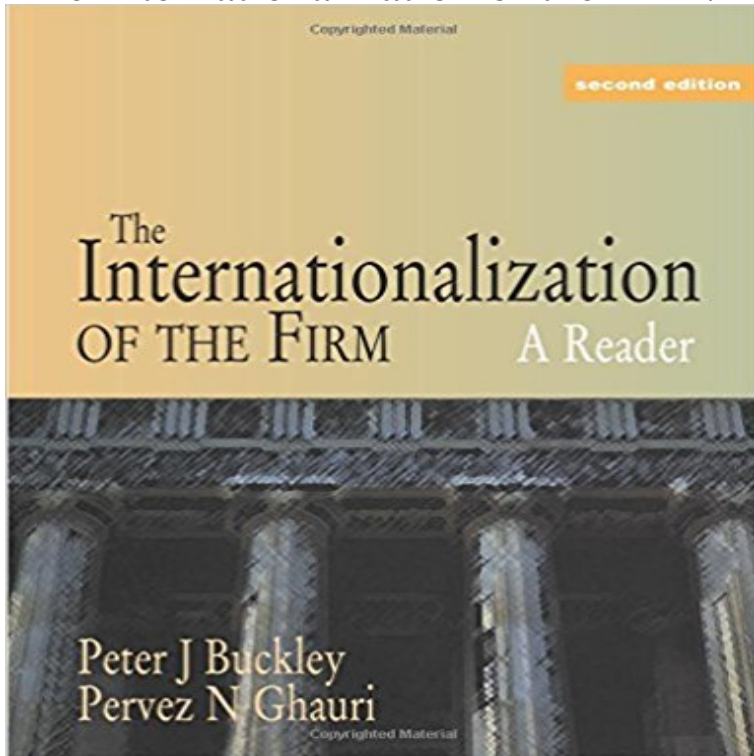


The Internationalization of the Firm: A Reader
