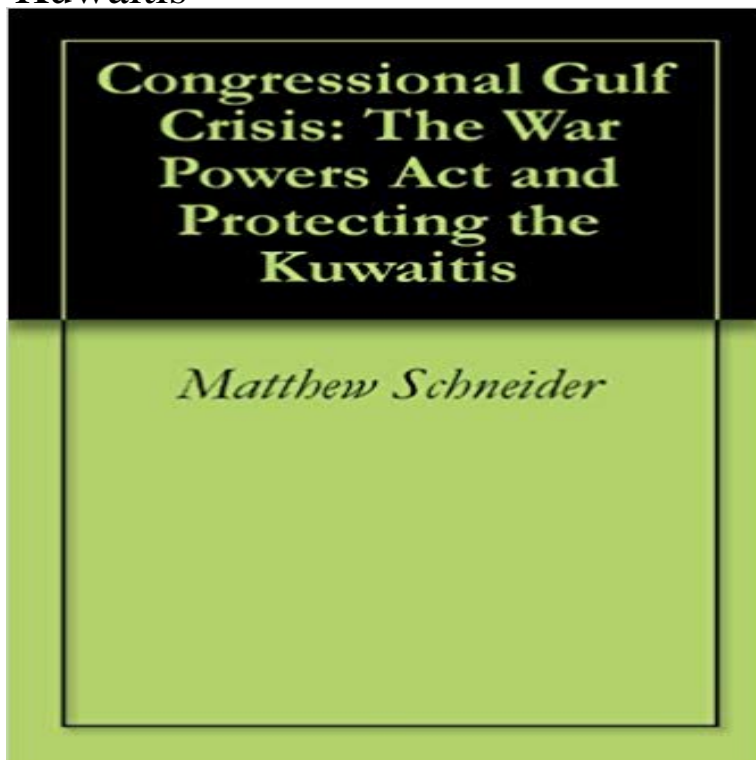


# Congressional Gulf Crisis: The War Powers Act and Protecting the Kuwaitis
