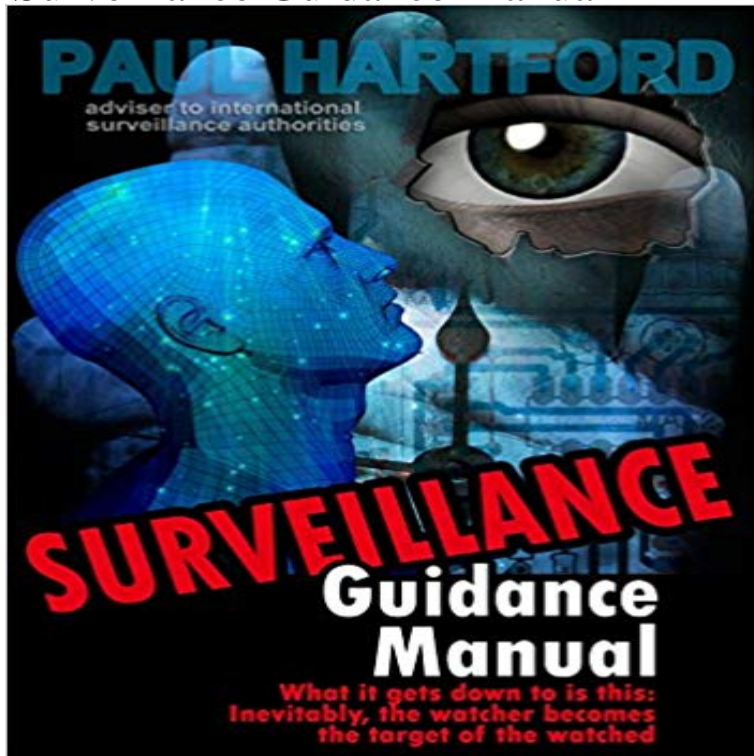


Surveillance Guidance Manual
